WHEREAS, in order for Creditor to sell printing to Debtor, it is hereby agreed that:

The Guarantor does hereby guarantee to the Creditor the full, prompt and unconditional payment, upon the due date, of each and every debt of the Debtor, and the full, prompt and unconditional performance of every term and condition of any transaction to be kept and performed by the Debtor.

If the Debtor shall default in the payment of any debt or shall otherwise be in default under any term or condition of any transaction, the Creditor may make demand upon the Guarantor for payment of all debts becoming due by reason of such default or any acceleration resulting therefrom. If payment in full of all such debts is not made within one week after such demand, then the Creditor shall have the rights and remedies provided for in the Uniform Commercial Code in force in the State of California at the date of this agreement. For failure to pay any sums due to the Creditor, the defaulting party shall be obligated to pay the reasonable attorney's fees and costs of the Creditor, if any.

This agreement is made in the State of California and shall be governed by and construed and interpreted in accordance with the laws of the State of California. This agreement cannot be orally changed.
